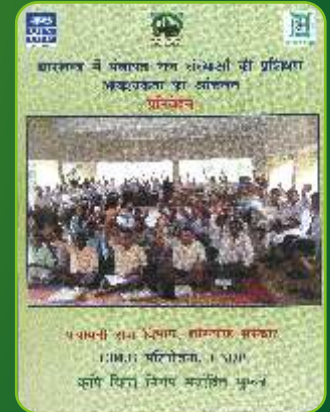
Service Offering

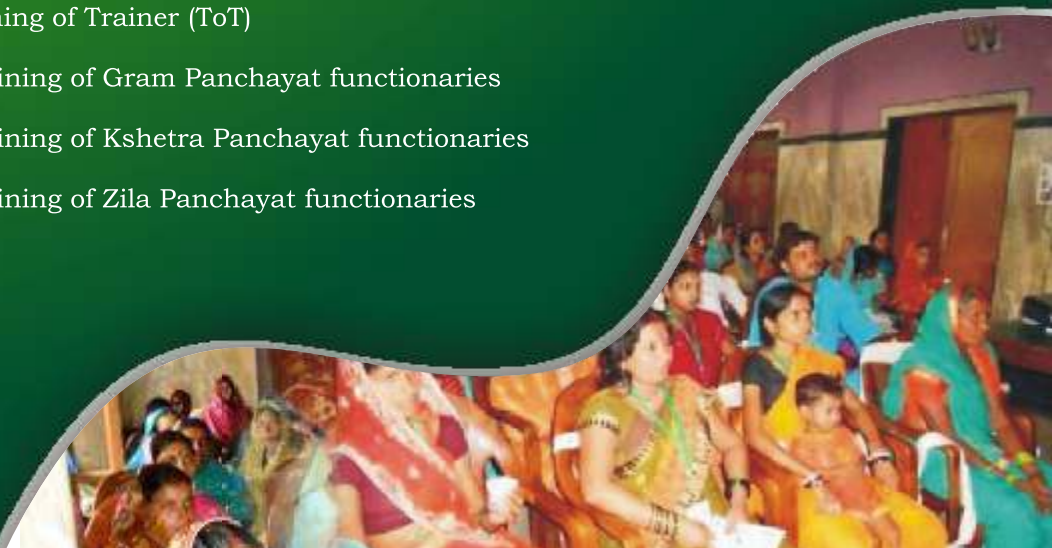

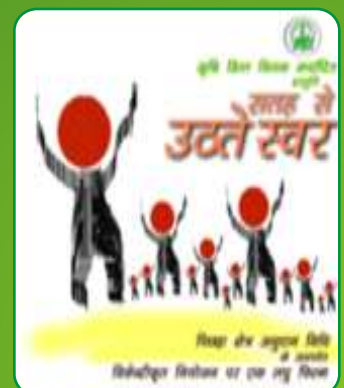
